

WELCOME TO THE MAY 2025 EDITION of NEWS and NOTES



PAWA has now completed three highly successful *Building Better Clubs* Workshops, held in Sorrento, Halls Head, and Mt Pleasant. These workshops have attracted around 100 attendees from a number of Clubs, and the feedback has been overwhelmingly positive. Participants have expressed strong appreciation for the opportunity to come together, share ideas, and learn from one another.

As we look ahead, we still have workshops scheduled for Albany, Bunbury, and Noranda, and we encourage Clubs in those regions to take part. These events are proving to be not only informative but also energising for those involved in Club leadership and operations.

A standout feature continues to be the breakout sessions, where attendees engage in open discussion and idea-sharing. These sessions have been consistently rated as the most valuable part of the workshops, as they allow Clubs to compare approaches, troubleshoot challenges, and explore new ideas together. Common topics of interest include insurance and organising outings (perennial favourites) as well as navigating the new Constitution and Standing Resolutions. Club members are also keen to learn how others handle specific issues and activities.

All of this reinforces one of my favourite sayings: "We all do the same thing, but we do it differently." These workshops highlight the diversity and creativity within our Probus community, showing that while our goals are shared, there are many ways to achieve them. By continuing to connect and learn from each other, we strengthen every Club across WA.

Another important point to note is that following extensive discussions between PAWA and PSPL over the past 6–8 months, we are pleased to announce a new collaborative initiative to establish new Probus Clubs in Western Australia. This will be a jointly managed effort, focused on identifying mutually agreed-upon locations that show potential for new Clubs. Importantly, before any steps are taken, existing Clubs in the vicinity will be consulted to ensure transparency, cooperation, and respect.

PAWA fully recognises that some Clubs may feel concerned or threatened by the establishment of new Clubs in "their catchment area". We are particularly mindful of Clubs that struggle to remain active primarily due to the dedication of enthusiastic Management Committee and Club members. Please be assured that PAWA values and respects all existing Clubs, and your voices will be heard throughout the process.

This initiative is about growth, not competition. Our aim is to expand the reach of Probus and ensure its long-term vitality in WA by welcoming new members and communities into the fold.

NEW PROBUS CLUB CONSTITUTION



A major issue currently engaging many Clubs is the review and adoption of the new PSPL "standard" Probus Club Constitution and Standing Resolutions. While interest is high and questions are being actively raised, many Clubs have yet to begin a thorough review of the implications of the updated Constitution or address the Standing Resolutions template provided by PSPL. PAWA welcomes this engagement and is available to assist Clubs through the process.

Some Clubs have already looked to make changes to the Constitution; however, it is important to stress that the PSPL "standard" Constitution should not be altered—except to specify the start and end dates of the Club's financial year. This is a critical requirement. Under the Associations Act, a Club that conducts its AGM before the end of its financial year is considered non-compliant. Any other additional proposed amendments to the Constitution must first be approved by PSPL before they can be adopted.

PAWA strongly suggests that rather than attempting to modify the Constitution, Clubs are encouraged to use the Standing Resolutions to tailor operational matters to suit their specific needs. The Standing Resolutions provide flexibility in how a Club conducts its activities and internal affairs without affecting its legal framework. Change to the Standing Resolutions do not require prior PSPL approval.

Once a Club has the support of its membership to adopt the new Constitution, it must lodge the document with DEMIRS (Department of Energy, Mines, Industrial Relations and Safety) along with a lodgement fee of \$40 and a Form05.

Note that DEMIRS identifies that there are two types of Constitutions from Incorporated bodies. The first is the "model" Constitution which follows the DEMIRS template. The second is a "custom" Constitution which does not follow the DEMIRS template. Both the current and previous PSPL Probus Club Constitutions are considered to be "custom".

The DEMIRS Form05 is essentially a checklist of the 19 points that any incorporated bodies' Constitution must address in order to conform with the WA Associations Act. On this Form05, you must identify which specific clause in your Constitution meets the 19 criteria set out in the Act.

Only after receiving formal endorsement from DEMIRS can the new Constitution be officially adopted by the Club. Standing Resolutions, on the other hand, require only Club membership approval and do not need to be lodged or externally endorsed.

RULES OF DEBATE FOR MEETINGS

All motions, questions and statements must be directed through the Chairman. It is best practice for motions to be put on the agenda so members have adequate time to consider matters properly before the next meeting. This avoids disadvantaging members who are not in attendance at the meeting and therefore unaware of the new business.

- A motion must be moved and seconded before being debated. If it is not seconded, the
 motion lapses. The mover may speak in support of the motion after it has been formally
 moved and seconded. There is an opportunity for members to discuss and speak for or
 against the motion. The motion is read aloud and voted on.
- If the motion is passed, it becomes a resolution.
- In order to maintain impartiality and to avoid conflict, the chairman may invite another member to move or second a motion.
- A notice of a motion by a member must be submitted in writing 21 days prior to the meeting.
- Any new agenda items raised during a meeting should be put on the agenda for the next meeting.

Refer to the PSPL Guidelines, rules of debate for meetings. Guide for Incorporated Associations in WA.

A Special Resolution requires a majority vote of 75% of members present and proxies, and 28 days written notice. E.G. changing the name, new Constitution etc.

Amending Standing Resolutions

A Standing Resolution may be moved from the floor with or without notice depending on the nature of the motion. For any existing Standing Resolution or a contentious issue, members should be given 14 days written notice.

PAWA is often asked questions about PSPL's National Insurance Program.



The National Insurance Program in Australia provides cover for approved activities such as an event organised by a club. This includes coverage for all participants at meetings, outings, tours, trips as well as interest groups (subject to terms and conditions of relevant policies). However, it is not designed for extended trips normally covered by travel insurance.

The approval of an activity should be reflected in the club's minutes. Consideration needs to be given to interest, location, cost and risk assessment, with sufficient information to understand what is being approved.

Keep your attendance lists for 13 months for insurance purposes. A tick against a name is sufficient.

Identify and assess any physical risks of the outing, activity or tour as part of the approval process. Matters that should be considered include:

- Has the venue and the transport to and from the venue been assessed to minimise the risk of injury to members, e.g. is an additional step required to get onto a bus?
- How much walking is involved? Are there lifts or ramps for those participants that may need them?
- Is there appropriate signage?
- Is the activity weather dependent or is there likely a change in the weather?
- Can the attendee participate on their own or do they need the assistance of a carer?
- Are there any risks of members slipping, falling or tripping over as a result of wet surfaces, loose cables, poor lighting, uneven steps etc?

The suggested Registration Form for Outings, Activities and Tours provided by PSPL is to encourage members and visitors to consider whether they are physically capable of participating.

Whether or not this form is completed does not affect the level of insurance provided under the National Insurance Program/s. The form is not a condition of insurance.
